Specific conditions :-

- 1. Library facility should be improved including facilities for viewing cassettes and laser discs (LDs).
- 2. Tuition fees may be revised keeping in view the expenditure involved.

- 7. Proper and regular maintenance support system has to be created.
- 8. Ample practice time to be the students be provided.
- 9. Revised theater be established for regular viewing and studying of Indian and World master piece.
- 10. A Black & White motion picture laboratory should be established to facilitate training of cinematography students.
